3. Financial Report. (Gorham)

There is no final end of the year reports as the financial status has changed little since the last meeting. The final end of year reports and CFSOJ report will be submitted at our Annual/Board meeting on Feb 12th with a full discussion. Gorham did comment that the initial CFOSJ report and our checking account shows our Fund Balance at \$1,126,775.65 at year end. This is a 16% increase from 2020.

5. Selection of Schlegel Endowed Leadership Scholarship. (Ito) See the 3 attachments to this agenda: Andy Ly, Irene Chia, and Kimmy Dovan. Established in 2010, this scholarship is "presented annually to a pharmacy student recognized for the potential of exceptional leadership in the profession after graduation through exemplary behaviors and actions as a student and professional in training."

Focus: Must demonstrate the potential for exceptional leadership in the profession after graduation.

Criteria:

- a. Must be an Alpha Psi full time student in good academic standing and currently in his/her final professional year of study.
- b. Must demonstrate financial need.
- c. Must have respect of his or her peers.

The Board selects the winner from the three candidates selected by the Awards Committee.
